We confirm the receipt and release to the market of an announcement regarding:

Ceasing to be a substantial holder

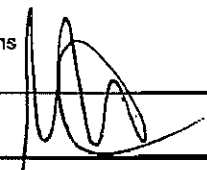

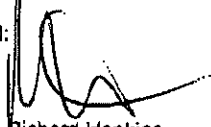
